

NITRO CITY COUNCIL  
MINUTES  
MAY 18, 2021

CALL TO ORDER: Mayor Dave Casebolt called the meeting to order at 7:00 pm in Council Chambers with the following present: Recorder Rita Cox, Ward 1 Councilwoman Donna Boggs, Ward 2 Councilwoman Cynthia McGill, Ward 3 Councilman Joe Murphy, Ward 4 Councilman Michael Hill, Councilwoman at Large Emily Barr, Councilmen at Large Bill Javins and Andy Shamblin, and City Treasurer John Young. City Attorney Johnnie Brown was not present.

INVOCATION/PLEDGE OF ALLEGIANCE: The Invocation was given by Councilman Andy Shamblin and the Pledge of Allegiance was led by Councilman Joe Murphy.

APPROVAL OF COUNCIL MINUTES: Recorder Rita Cox said the minutes of the May 4 meeting were not ready.

OLD BUSINESS

OPEN BIDS ELECTRIC CAR: COUNCILMAN BILL JAVINS MADE THE MOTION THAT COUNCIL APPROVE THE BID RECEIVED FOR THE PURCHASE OF AN ELECTRIC POLICE VEHICLE WHICH WAS IN THE AMOUNT OF \$40,290.00 FOR TESLA MODEL 3 FOR USE FOR THE NITRO POLICE DEPARTMENT. THERE WAS A SECOND BY COUNCILWOMAN DONNA BOGGS AND VOTE WAS UNANIMOUS FOR THE MOTION.

STREETScape RESOLUTION: RECORDER RITA COX MADE THE MOTION THAT COUNCIL APPROVE THE RESOLUTION IN SUPPORT OF THE TRANSPORTATION ALTERNATIVE PROJECT AND AUTHORIZES MAYOR CASEBOLT TO ENTER INTO A CONTRACT WITH THE WV DEPT. OF TRANSPORTATION AND ADMINISTER GRANT FUNDS THROUGH PROVISION OF THE TRANSPORTATION ALTERNATIVE PROJECT. THERE WAS A SECOND BY COUNCILMAN MICHAEL HILL. THE MOTION CARRIED WITH A UNANIMOUS VOTE.

NEW BUSINESS

TREASURER REPORT: COUNCILMAN HILL MADE THE MOTION TO ACCEPT THE TREASURER REPORT WITH A SECOND BY COUNCILWOMAN BARR. THE MOTION PASSED.

PUBLIC COMMENTS: Joe Stevens said he will meet with the Kanawha Health Department for guidance in the running of the pool this summer in the wake of the pandemic and its aftermath.
