## The City of Nitro Convention and Visitors Bureau

### March 5, 2024

The Nitro Convention and Visitors Bureau met on Tuesday, March 5, 2024. The meeting was called to order at 6:00 pm by Chairman Bill Javins and held in Nitro City Council Chambers. Those attending the meeting in person were Bill Javins, Ivan Meadows, Susan Valleau, Bill Fortune, Matthew Lawrence, Cynthia McGill, Kato Moye, Julia Washington, Kelli Steele, and Dave Casebolt, Executive Director Joe Stevens was also present.

A quorum was determined, and the minutes were reviewed and a motion to accept the minutes of the previous meeting was made by Matthew Lawrence and seconded by Julia Washington. The motion was adopted.

A February financial report was presented by Joe Stevens and a motion to accept the report was made by Keli Steele and seconded by Julia Washington. The motion was adopted.

Nitro Firefighter Bobby Grishaber came before the board and request \$5000 from the CVB to be used to help purchase a new side by side for the Fire Department. With the trail expansion at Ridenour Lake and the age of the current piece of equipment the department is purchasing a new side by side. On a motion to approve the request by Ivan Meadows and seconded by Julia Washinton, the motion was adopted.

Joe Stevens presented to the board his director's report. Stevens reported that the event calendar was changed a bit and is now on the CVB website. The King Kat Bass Tournament officials are now looking to host an event in Nitro in 2025. Stevens and Steele attended the WVHTA's Hospitality University in White Sulpher Springs.

In New Business, Stevens gave an update on the Ridenour Lake Trail Expansion. Valleau provided an update on the museum's visitation and that the Vietnam Memorial continues to be a large draw for visitors. A ceremony honoring former CVB Board member and museum curator Carmen Kostelansky will be held in April. Matthew Lawrence gave the board an update on the booking of tournaments at the Athletic Complex for this coming season and that the complex will now be open whenever the weather permits. Moye talked about the happenings at Mardi Gra Casino & Resort and that February had positive numbers. He also mentioned an upcoming remodeling of the hotel. Cynthia McGill announced there will be open mic nights at Living Memorial Park beginning in May.
