The City of Nitro Convention and Visitors Bureau

October 3, 2023

The Nitro Convention and Visitors Bureau met on Tuesday, October 3, 2023. The meeting was called to order at 6:00 pm by Chairman Bill Javins and held in Nitro City Council Chambers. Those attending the meeting in person were Bill Javins, Ivan Meadows, Julia Washington, Kato Moye, Bill Fortune, Tracy Toler, Matthew Lawrence and Dave Casebolt, Executive Director Joe Stevens and guest WVDOH Engineer Ryan Canfield and city council woman Cynthia McGill.

A quorum was determined, and the minutes were reviewed and a motion to accept the minutes of the previous meeting was made by Matthew Lawrence and seconded by B. The motion was adopted.

A September financial report was presented by Joe Stevens and a motion to accept the report was made by Matthew Lawrence and seconded by Ivan Meadows. The motion was adopted.

The meeting's guest speaker was Ryan Canfield, District 1 WVDOH Engineer. Canfield provided the board an update on the I-64 construction.

Joe Stevens presented to the board his director's report. The CVB is still working with Nitro High School Students to produce This Week In Nitro, The board learned of the CVB's involvement in the upcoming Halloween Hoedown and the 25th Anniversary of the 1998 State Championship Football Team and that the CVB was the game sponsor.

In New Business, Cynthia McGill provided an update on the museum's visitation, which continues to be up and how the museum will be involved in the upcoming Hoedown. Matthew Lawrence informed the board of a Pickleball Tournament in November. Kato Moye gave an update on operations at Mardi Gras Casino & Resort.
