# The City of Nitro Convention and Visitors Bureau

#### September 5, 2023

The Nitro Convention and Visitors Bureau met on Tuesday, September 5, 2023. The meeting was called to order at 6:00 pm by Chairman Bill Javins and held in Nitro City Council Chambers. Those attending the meeting in person were Bill Javins, Carmen Kostelansky, Ivan Meadows, Julia Washington, Kato Moye, Bill Fortune, Tracy Toler, Kelli Steele, Matthew Lawrence and Dave Casebolt, Executive Director Joe Stevens and guest Kanawha County Commissioner Lance Wheeler.

A quorum was determined, and the minutes were reviewed and a motion to accept the minutes of the previous meeting was made by Ivan Meadows and seconded by Matthew Lawrence. The motion was adopted.
